Data Incident Response

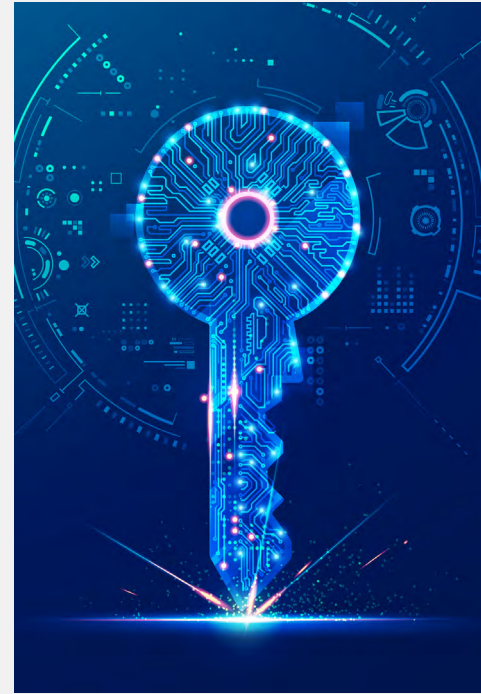

Key preparatory measures include developing clear incident response procedures in accordance with jurisdictional requirements, maintaining up-to-date data inventories, and establishing notification templates and communication channels for both regulatory reporting and data subject notifications.
